# **Application Guidelines:**

- ➤ Guidelines of the Council of Higher Education for International Student Admission: Applicants who do not meet the conditions specified in the "Applicants" section of these guidelines are not eligible to apply.
- ➤ Mersin University Associate and Undergraduate Programs International Student Admission, Registration, and Acceptance Directive

### **Application Details:**

- **Applicants are required to upload the following application documents to the application system.**
- Document Showing Your Nationality: Applicants must upload the following documents to verify their nationality or nationalities:
- a) **Passport:** Passport of the country of citizenship or a translated version.
- b) Identity Document: National identity card (those with dual citizenship must upload both identity cards).
- c) Blue Card: Applicants who possess and/or are eligible for a Blue Card must upload their Blue Card.

**Blue Card:** A card issued upon request to individuals who were Turkish citizens by birth but lost their Turkish citizenship with the permission of the Ministry of Interior.

**Note:** Applications from candidates who possess but do not declare or upload their Blue Card will not be considered, and they will not be entitled to any rights.

- d) Temporary Protection, International Protection Document
- e) Candidates whose nationality includes Turkish citizenship must upload the certificate of identity register copy obtained from E-government.
  - **Document Showing Exam Results:** Depending on the type of score required for the application, the candidate must upload one of the following exam results and diploma score documents.
    - a) TR YÖS
    - b) Diploma Score
    - c) GCE AL
  - Secondary Education Status Document: Diploma or graduation certificate indicating completion of secondary education, or, Transcript of records, or Document indicating enrollment in the final year of secondary education and the translation of this document

**NOTE:** Candidates applying with their Diploma Score must upload an authenticated document showing their Grade Point Average to the application system.

## Information Regarding Application, Evaluation, and Placement

- ➤ For applicants, the validity period of the TRYÖS score, which is in the status of university entrance exam, is two years.
- ➤ Candidates can apply with only one of their TRYÖS or GCE AL exam scores, or their Diploma Grade Point Average.
- ➤ Applications based on Diploma Grade Point Average will not be accepted for programs in the Faculty of Medicine, Faculty of Dentistry, and Faculty of Pharmacy.
- ➤ In the evaluation of candidates' applications, their application scores are converted into TRYÖS scores. The obtained TRYÖS score is used for placement.
- ➤ For the Faculty of Medicine, the minimum base score for application to the Medicine program must be 325 (TRYÖS).
- ➤ For the Faculty of Dentistry, the minimum base score for application to the Dentistry program must be 300 (TRYÖS).
- For the Faculty of Pharmacy, the minimum base score for application to the Pharmacy program must be 280 (TRYÖS).
- ➤ For the Computer Engineering and Electrical and Electronics Engineering programs of the Faculty of Engineering, the minimum base score for application must be 260 (TRYÖS).
- For programs in the Faculty of Architecture, the minimum base score for application must be 260 (TRYÖS).
- For other undergraduate programs, the minimum base score for application must be 200 (TRYÖS).
- For associate degree programs, the minimum base score for application must be 150 (TRYÖS).
- ➤ Applications of candidates who are placed in a unit but fail to register will be considered invalid for subsequent placement rounds.
- Candidates have the right to make a maximum of 5 (five) preferences.

### **Payment of Application Evaluation Fee**

Application Evaluation Fees must be paid between June 24, 2024, and July 7, 2024.

### **Payment Procedures**

- During the payment of the application fee into the Mersin University account, any Transfer or EFT fees charged by the bank are not included in the aforementioned Application Evaluation Fee.
- The Application Evaluation Fee cannot be carried over to subsequent years.
- Applications of candidates who do not pay the Application Evaluation Fee, or upload bank receipts with unreadable resolution or incorrect payment information, will not be accepted.
- Fees paid by applicants whose applications are deemed invalid or rejected will not be refunded or transferred.
- The responsibility for the correct payment of fees lies with the applicant.
- Payments for those paying in Turkish Lira can be made via EFT/Transfer, while those paying in Dollars can be made using the "swift code."
- Only your Candidate Number/User Name should be entered in the description section of the receipt (no other information should be included besides the candidate number acquired or to be acquired during the application).
- The Application Evaluation Fee payment must be made in the amount of 2,500 Turkish Liras (TL) or 80 US Dollars (USD). Payments should not be made in other currencies (such as EURO, etc.).

Applicants who pay the application fee should only write their <u>"CANDIDATE NUMBERS"</u> in the description section of the receipt. Receipts containing information other than the candidate number will not be accepted, and refunds will not be issued.

Note: Be sure to keep your payment receipt. (If any issues arise, you will be asked for the receipt.) Your application will be approved after your payment information is verified. Applications of candidates who do not pay the application evaluation fee will not be considered.
